



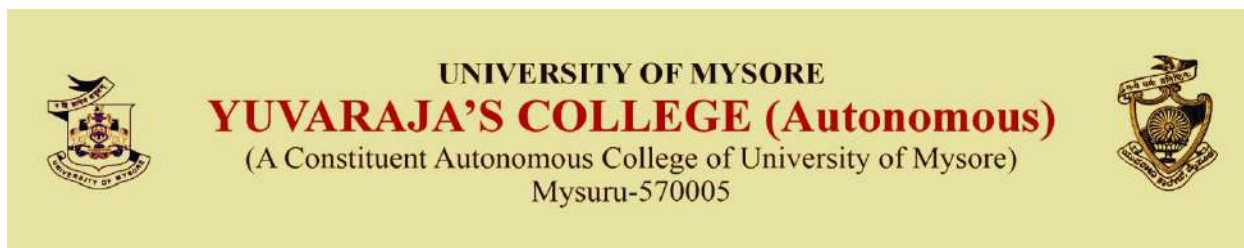

The Strategic Plan for the Period 2021-22: The plan has been revised to meet the challenges in incorporating major policy changes proposed by National Education Policy 2020. POLICY DOCUMENT FOR DIVYANGJAN STUDENTS AND STAFF

- The person with Disabilities Act 1995 indicates that differently-abled persons should have access to education at all levels. In higher education sector, the university Grants Commission (UGC) is assisting universities in the country to promote inclusivity for differently abled students by way of guidelines.
- Yuvaraja's College (Autonomous) is evolving as a Divyangjan friendly Environment to level up the participation and learning experience of differently abled students. Some of the policies have already been implemented in the operational systems of the college and few others are in the pipeline.
- The college makes provision for scribes during the examination for the needy Divyangjan students as per the university and government rules and regulation.
- With the aim of providing a barrier-free infrastructure as far as possible, the college has added ramps for easy access to the class rooms for the old building. Additional ramps that would provide easy accessibility to all physical infrastructure are planned for future construction.
- Since the college is housed in a heritage building alterations to the original structure are avoided and hence lifts not added to the main building, instead provisions are made to cater to the needs of the differently abled staff and students. Support staff of the college are allocated duty to provide personal assistance for availing the service of the college administrative office and the registers of daily log structure. The new RUSA building that is coming up in the college will be provided with the lift.
- Navigation through the campus is made user friendly for differently abled and others with the help of clear and simple, directional signage's, tactile path lights, display boards and signposts.
- Assistive technologies with KOHA software is made accessible in the library.
- Human assistance is always extended for the needy persons.
- Access for limited mobility individuals is notified through signage and contact line number.
- Dedicated washrooms are available for Divyangjan students.

POLICY DOCUMENT ON THE GREEN CAMPUS

The Green Audit and Eco Club is an initiative to promote environment friendly practices that help in sustaining a green campus. The green campus concept offers our institution the opportunity to take the lead in defining a work culture that is eco centric and developing new and sustainable solutions to environmental, social and economic needs of mankind. A large part of the campus is left in its natural form thereby conserving the existing environmental resources.

Objectives of the Green Campus

As a preliminary step to the functioning of the Green Audit and Eco Club Is the Establishment of committee within the Organizational structure of the college comprising stakeholders from various backgrounds. The policy documents further spells out the strategies adopted to make this initiative functional.

We believe that greening the campus is all about eliminating wasteful, inefficient and non-viable conventional sources of energy for its daily requirements of power supply. Proper purchase, handling and disposal of environment friendly supplies and effective recycling are the foremost objectives of the eco club. The administration of the college commits to the idea that everyone has to work out the time-bound strategies to implement green campus initiatives and that these strategies need to be incorporated into the planning and budgeting process of the college as well. Every individuals belonging to Yuvaraja's college is expected to work towards the achievement of the goals of the club whether he or she may be a student, a member of the faculty or the support staff of the college.

Even visitors to the campus are urged by the way of display of reminders to nurture a culture of self – sustainability and maintain an eco-friendly campus. In short, the college strives to keep an ecofriendly approach at the core of all activities. The club enables the institutions to develop the campus as a living library for a positive change.

Role of the Green Audit Eco Club

Outreach and educate for a green campus must derive from top to include the needed commitment and involvement from all the stakeholders. This way the Chairperson and members of the club chalk out various programs and regularly evaluate the success of such programs. Bearing in mind the challenges of keeping the best-intentioned project cohesive for wide participation, a board based plant is left open for customization as per the need of the time without compromising the essential values of the club. Thus in view of this, the committee will plan and execute to:

1. Seek feedback from all stakeholders in order to keep the Green Audit and Eco Club initiatives running throughout the year.
2. Analyze the effects of the environment on Campus to determine the areas that needs improvement.
3. Create environmental awareness programs in the campus.
4. Mission and concepts set for the Green Audit and Eco club
5. Link the club activities to academics.
6. Organize awareness programs for the students, faculty and society
7. Chart out yearly planner for the college, local community and stakeholders.
8. Develop a strategic plan and create student teams to carry out specific tasks of the strategic plan. For instance, a plan to save energy at the college level with a time-bound plan to install solar power station mandatorily either at the top of the college building or in open field , this will enable the college to have 24*7 power Supply
9. Phase out CFL and conventional light source such as bulbs and tube lights, halogen and mercury street/campus lights and replace them with LED's.
10. Conduct an Annual Green, Environment and energy Audit.
11. Purchase only energy efficient systems.
12. Evaluate daily operations in terms of pollution prevention, waste stream management, and energy efficiency with a stress on reducing, reusing, recycling, and repairing whenever possible.

PROMOTION OF "CONSERVATION OF ENERGY" IN AND OUTSIDE THE COLLEGE"

- Activate power management features on your computer and monitors that it will go into low powered mode when it is not in use.
- Turn off your monitor before you leave the campus.
- Activate power management features on your laser printer.
- Whenever possible, shutdown rather than logging off.
- Turn off unnecessary lights and use day light instead.
- Avoid the use of decorative lights.
- Use LED or Compact florescent bulbs.
- Keep lights off in conference rooms, classrooms, lecture halls when they are not in use. Use fans only when it is necessary.
- Un-plug appliances plugged into power strips (like TV's, refrigerators, AC's tea/coffeepots, printers, faxes and chargers etc.

RESEARCH POLICY

As per the UGC guidelines Yuvaraja's College (Autonomous) has its own research policy as follows.

1. Eligibility test (SLET) or State Eligibility test (SET) conducted by the bodies accredited by the UGC for the said purpose qualified person shall be taken as research candidates.
2. After enrolment candidate has to be qualify in PhD course work examination conducted by each department in respective subject.
3. Course Work qualified candidate has to do registration as per the university guidelines.
4. After registration Doctoral Committee monitor the progress of the research of the candidate.
5. Overall research is monitored by the college advisory committee.
6. The candidate has to publish two research papers from his/her PhD work in a refereed journal.
7. Before Submission of the thesis the candidate has to clear the Pre thesis colloquium as per the university guidelines.
8. The PhD thesis will be evaluated by two examiners.
9. An open viva voce of the candidate will be conducted.
10. The Candidate must present his/her research work in seminar/conference sponsored by UGC/CSIR or any other agencies recognized by Government of INDIA.
11. The fulfilment of the above conditions leads to PhD notification of the Candidate making which will be certified by Registrar (Evaluation) of the University of Mysore.

There is a Research Committee to oversee the research activities of the College.

The Composition of it is as Follows:

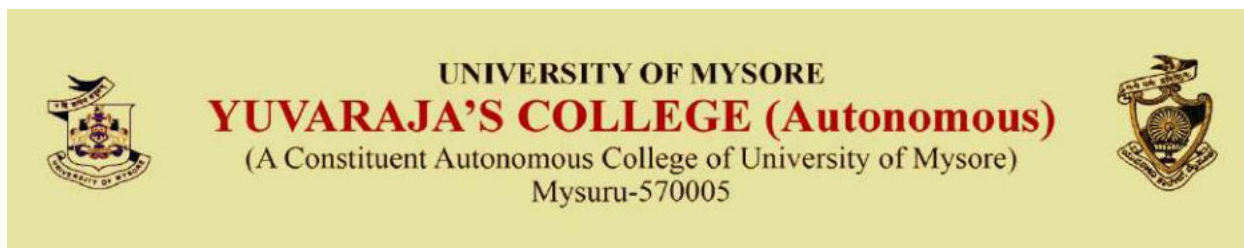
The College has evolved a long term policy to encourage high-Quality research leading to innovations. This process has progressed in step-by-step manner to establish institutions, develop linkages between the college with state, national and international institutes. College teachers can apply for research funding from various granting agencies like VGST from state government, UGC, DST, DBT etc., from Central government and also from private funding agencies.

Many Teachers in our college are recipients of international/ national/ state/university awards, fellowships, educational awards. The most significant step is to establishing the college career Hub (CCH), promoting skill development, entrepreneurship and innovative activities. The college has planning to centralize all the instrumentation facility in a room sophisticated scientific equipment (IR, Spectrophotometry, and Ph.-meter, Conducted meter, Flam-photometer etc.

The college has many JRF's, SRF's and other research fellows. Annually many researchers use the college instruments facilities for both individuals' researchers and collaborative research pursuits. Many Departments in the college has UGC, DST, DBT, ICMR and VGST grants.

Our University has a code of ethics to check malpractices and plagiarism in research for all the PhD theses submission. The progress of research work is monitored by Doctoral Committee. The college has provided internet facilities to all the research scholars as well as research guide, library facilities to all faculties, research scholars, and master course students for research activities. Several international/national/state level/university level seminars, symposia, workshops, faculty development programs and special lectures are regularly organized to meet the emerging academic and research needs.

AND

N. Ranga Rao & Sons Pvt. Ltd., the Second Party, and represented herein by its Authorised Representative, (hereinafter referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as '**Parties**' and individually as '**Party**') as

WHEREAS:

- A) First Party is a Higher Educational Institution named:
Yuvaraja's College, A constituent Autonomous College of the University of Mysore
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) **N. Ranga Rao & Sons Pvt. Ltd., the Second Party** is engaged in the Business, Manufacturing, Skill Development, Education and R&D Services in the fields of –Manufacturing and exports of incense sticks, puja accessories and related products
- F) **N. Ranga Rao & Sons Pvt. Ltd., the Second Party** is promoted by the NR Group of entrepreneurs based in Mysore and having its manufacturing facilities at various locations in Mysuru, Karnataka, India.
- G) Give related information, its branches, and dimensional information about the industry concerned with whom the MoU is sworn.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.3 **Industrial Training & Visits:** Industry and Institution interaction will give an

insight in to the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.

- 2.4 **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of Manufacturing and exports of incense sticks, puja accessories and related products.
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
- 2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.7 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 **Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs; and will facilitate placements for at least 3% of the students. The Second Party will itself absorb at least three percentage of the trained students.
- 2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein
- 2.10 There is no financial commitment on the part of the **Yuvaraja's College, A constituent Autonomous College of the University of Mysore**, the First Party and **N. Ranga Rao & Sons Pvt. Ltd.**, the Second Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **N. Ranga Rao & Sons Pvt. Ltd.**, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Training Partner** or **N. Ranga Rao & Sons Pvt. Ltd.**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **Mysuru**.

3.3 Exchange of research scholars, scientist, staff and students in each other academic programmes and provide local hospitality for them at respective places.


3.4 The parties may establish a "joint working group" to manage and execute the cooperative activities mentioned in this MoU.





7. Neither this agreement nor any activities described herein shall be constructed as creating a partnership, joint venture, agency or other such relationship. Both parties and nothing agreement represents a non-exclusive relationship between the parties and nothing contained herein shall preclude either party from participating /initiating a similar relationship with third parties.
8. Neither party shall issue any press release, public announcement or other such disclosure concerning this agreement without other party's prior consent as to such release announcement.
9. This MoU may not be amended without the prior written consent of both the parties.
10. This memorandum shall commence from the date of execution of the same and shall be continued for a period of **five years** from the date thereof and be automatically renewed for a successive period of three years unless either party notifies in writing to the other party of its intention to terminate this MoU ninety days in advance.






